SUPPLEMENTARY AFFIDAVIT OF RUTH ALEIXO (Sworn September 24, 2024)

- I, Ruth Aleixo, of the Town of Oakville, in the Province of Ontario, MAKE OATH AND SAY:
- 1. I am a legal assistant at Lerners LLP, which is counsel to the Applicant, the Royal Bank of Canada ("RBC"). I have been involved in matters related to this file, and as such have personal knowledge of the matters to which I depose herein. Where this affidavit is based on information received from others, I have stated their source and verily believe such information to be true.
- 2. I swear this affidavit in support of RBC's application to appoint a receiver.

- 3. On July 18, 2024, RBC's counsel and Ibrar Khan, the principal for the debtor EA Logistics Inc. (the "Debtor") appeared before this court. RBC's motion to appoint a receiver was supposed to be heard that day no responding materials were filed. However, Mr. Khan attended and the court granted a short adjournment for him to either seek counsel or bring his motion for leave to act on behalf of the Debtor. The court noted that Mr. Khan had been served with the application in May 2024 and in June indicated he was seeking counsel. Attached as Exhibit "A" to my affidavit is a copy of the court's endorsement dated July 18, 2024.
- 4. I am advised by Emily Fan, counsel at Lerners with carriage of this matter, that, to date, no counsel for the Debtor has appeared and Mr. Khan has not brought any motion for leave to act on behalf of the Debtor.
- 5. On July 24, 2024, Ms. Fan exchanged emails with Mr. Khan, asking if the Debtor would consent to a bankruptcy, since he had advised that the Debtor was no longer an operating business and attempting to unwind the share purchase agreement dated July 17, 2023. Mr. Khan responded and advised he did not want a legal battle, and operations had ceased. Attached as Exhibit "B" to my affidavit is a copy of Ms. Fan's email exchange with Mr. Khan dated July 24 25, 2024.
- 6. I am advised by Ms. Fan that on July 26, 2024, she had a call with Mr. Khan. I am advised by Ms. Fan that on that call, Mr. Khan indicated that he would likely consent to a bankruptcy or receivership order, and would obtain legal advice and be in touch. Attached as Exhibit "C" to my affidavit is a copy of Ms. Fan's email to Mr. Khan dated July 26, 2024, confirming their conversation.

- 7. By email dated August 5, 2024, Mr. Khan indicated that the Debtor would be proceeding with the bankruptcy, and was speaking with a lawyer to commence the process. By email dated August 6, 2024, Ms. Fan inquired when the Debtor would commence the bankruptcy process. Ms. Fan followed-up on August 7, and again on August 14 and August 25, 2024. Mr. Khan responded on August 23, 2024, advising that he would reach out to msi Spergel inc ("spergel") to proceed with the bankruptcy/ Attached as Exhibit "D" to my affidavit is a copy of the emails dated August 5 to September 23, 2024.
- 8. As of September 19, 2024, Mr. Khan still had not contacted spergel to commence the bankruptcy. So, Ms. Fan wrote to Mr. Khan on September 19th asking if the Debtor would oppose the receivership, and requested a response by end of day on September 20, 2024. Receiving no response, Ms. Fan followed up again on September 23, asking for a response by end of day. I am advised by Ms. Fan that she received no response and has heard nothing further from Mr. Khan.

They (old ownership) based on messages from then RBC account manager Ryan said everything was done. Ryan in phone conversations told me to continue working as things are in progress. He gave me a few conditions which I fulfilled.

Then RBC decided to terminate the relationship and demand payment. This affected everything. Cash crunch occurred further because based on the financials the old ownership provided the revenue was not there.

The old owners had kept all the assets under their own corporations and removed the equipment. One of the old owners, Khurram Shahzad, even registered a new sole proprietorship "Khurram Shahzad" operating as "EA Logistics" and collected receivables and deposited them.

So I had no choice to cease operations, loosing over \$1.5 million invested of my own money. I lost clients which I have not been able to recover. I lost reputation. I have unpaid drivers and owner operators.

I don't want a legal battle. I cannot afford it. I know there is no personal guarantee on my part as cleared by Raj Grewal earlier, but EA has no assets. Nothing, not even computers. They took all the computers etc.

Muhammad Usman will be taking back ownership.
