

We are writing to you in connection with the Factoring Agreement, General Absolute Assignment of Receivables, General Security Agreement, all dated December 5, 2021, the Specific Security Agreement made as of June 28, 2023, and the Equipment Lease Agreement dated December 15, 2023. Each of the foregoing agreements was accepted by each of the Borrower and Guarantors, as borrowers, the Guarantors, as guarantor, and MHCCA, as lender. The Factoring Agreement Letter was amended by the Second Amending Agreement, dated October 20, 2022; the Third Amending Agreement dated December 29, 2022; and the Fourth Amending Agreement dated March 7, 2023.

Capitalized terms used herein and not otherwise defined have the meanings given to them in the Factoring Agreement, General Security Agreement, and Equipment Lease Agreement.

According to MHCCA’s records, the Borrower is indebted or otherwise liable to MHCCA for the amounts of CAD\$1,546,316.80 and USD\$644,458.37 (collectively, the “**Indebtedness**”) as of today’s date. The Guarantors have guaranteed the repayment of the Indebtedness under their respective guarantee agreements (collectively, the “**Guarantees**”).
