#### **BANKRUPTCY ORDER**

Upon the application of Royal Bank of Canada, a creditor, having an office in the City of Toronto, in the Province of Ontario, issued on the 18th day of November, 2024, and upon reading the Application for Bankruptcy Order, the Affidavit of Verification of Ram Muralitharan sworn the 18th day of November, 2024, the Affidavits of Service of Cristian Delfino each sworn the 31st day of December, 2024, the Consent of msi Spergel inc. ("**Spergel**") dated the 18th day of November, 2024 to act as trustee of the property of Moore Brothers Transport Ltd. (the "**Debtor**"), and it appearing to the Court that one or more of the following acts of bankruptcy has been committed:

- (a) that the Debtor has made a fraudulent gift, delivery or transfer of its property or of any part of it;
- (b) that the Debtor has transferred its property or any part of it, or has created any charge on it, that would under the *Bankruptcy and Insolvency Act* (Canada) be void as a fraudulent preference;
- (c) that the Debtor has exhibited to any meeting of its creditors any statement of its assets and liabilities that shows that it is insolvent, or has presented or caused to

be presented to any such meeting a written admission of its inability to pay its debts;

- (d) that the Debtor has given notice to any of its creditors that it has suspended or that it is about to suspend payment of its debts; and/or
- (e) that the Debtor has ceased to meet its liabilities generally as they became due, in that it has failed to pay its obligations to the applicant creditor, Royal Bank of Canada, and to other creditors,

1. **THIS COURT ORDERS** that the Debtor be and is hereby adjudged bankrupt, and a bankruptcy order be and is hereby made against the Debtor on this date.

2. **THIS COURT ORDERS** that Spergel, of the City of Toronto in the Province of Ontario, be and is hereby appointed as trustee of the estate of the bankrupt Debtor.

3. **THIS COURT ORDERS** that the trustee give security in an amount to be fixed by the Official Receiver pursuant to subsection 16(1) of the *Bankruptcy and Insolvency Act* (Canada).

4. **THIS COURT ORDERS** that the costs of the applicant, Royal Bank of Canada, be paid out of the assets of the estate of the bankrupt Debtor on taxation thereof.
